






Reefer trades are trending below historical growth rates

Refrigerated Commodities

Frozen

Proteins, Fruit/Vegetables, Confectionary, Packaged goods

Chilled

- Pharmaceutical, Fruits, Dairy, Vegetables, Nuts, Meats

• Temperature Controlled

- Temperature sensitive raw material (Seasonal)



Components of Refrigerated Cold Chain:

- Product Preparation Variables
 - Slaughter, Harvest, Processing, Packaging, Chilling, Blast Freezing
- Warehousing Capacity
 - 1:100 ratio refrigerated to Dry facilities
- Equipment Requirements
 - Reefer container, Pre-tripping, Chassis, Gen-set, Landside plugs
- Government Approval & Certificates
 - USDA Health Certificates, FDA, Certificate of Origin, Fito Sanitary, etc
- Port Operation & Vessel reliability
 - Vessel Schedules (ERD), Plug ins, on dock charges



Beneficial Cargo Owners: Challenges & Opportunities

- Geopolitical Risks: "Casino Royal"
 - Embargo's, tariff's, customers duties
- Animal & Plant Health Disease
 - AI (Avian Influenza), ASF (African Swine Flu), Foot & Mouth Disease, Plant canker/infestation
- Production interruption
 - Labor, Weather, Natural Disasters, Pandemics
- Unpredictable supply chain Cost
 - Government approval: USDA & FDA
 - Plug in electricity fee's, Detention/Demurrage, On dock charges, Rail ramp charges
- Companies that anticipate challenges and build resilient Cold Chains can better manage costs



Cold Storage & Sustainability

- 78% of USA Cold Storage Warehouse is 20 years old.....
- Capacity expansion in USA is move forward aggressively
- 1:100 Ratio refrigerated to dry facility
- Industry leaders are driving the conversion quicker
- Carriers driving the global green fuel initiative that will be passed to the consumer
